3. The bid price shall be F.O.B. Lyon County Landfill, Lynd, Minnesota, in first class operation condition, with acceptance subject to Environmental Department inspection and approval.
4. The bid must be made out in ink or typewritten. No bids made out in pencil shall be accepted.
5. Completed manufacturer's specifications, illustrated descriptive brochure shall be submitted and attached with each bid. Insufficient descriptive information shall be cause for rejection of the bid.
6. Payment to successful bidder shall be within 30 days after delivery to Lyon County Landfill.
