Administer WCA Program for Lyon County. Lyon County has delgated WCA administration to the Lyon SWCD, and transfers complete WCA base grant dollars to the SWCD. The SWCD will administer all aspects of WCA; assisting land owners with exemption decisions, no-loss decisions; replacement plans, and banking plans. The SWCD will submit required reporting. The SWCD will attend available training.		Lyon SWCD is responsible for administering the WCA program, and submitting required reports. Necessary administrative monies in the amount of \$8,630 were passed on to the Lyon SWCD. End of year report was submitted to BWSR.				
		Lyon SWCD provided wetland related assistance to landowners. Assistance included boundary and type determinations, no-loss and exemption decisions, review of wetland monitoring reports, and review of drainage projects. Information was provided to the public through one on one contacts, mail, newsletters and the media. Potential violation sites were investigated. Staff attended wetland related training.
