To the Board of County Commissioners of Lyon County, Minnesota:

Sirs: In accordance with the advertisement of the County Auditor inviting Proposals for the improvement of the sections of highway herein before named, and in conformity with the Contract, Plans, Specifications and Special Provisions pertaining thereto, all on file in the office of the County Auditor:

(I)(We) hereby certify that (I am) (We are) the only person(s) . . . interested in this Proposal as principal(s) . . . ; that this Proposal is made and submitted without fraud or collusion with any other person, firm, or corporation whatsoever; that an examination has been made of the site of the work and the Contract form, together with the Plans, Specifications and Special Provisions for the improvement.

(I)(We) understand that the quantities of work shown herein are approximate only and are subject to increase or decrease; that all quantities of work, whether increased or decreased within the limits specified in 1903 of the Specifications, are to be performed at the unit prices shown on the attached schedule, and that at the time of opening bids totals only will be read, but that comparison of bids will be based on the correct summation of item totals obtained from the unit prices bid, as provided in 1301 of the Specifications.

(I)(We) propose to furnish all necessary machinery, equipment, tools, labor and other means of construction and to furnish all materials specified, in the manner and at the time prescribed, all in accordance with the terms of the Contract and the Plans, Specifications, and the Special Provisions forming a part thereof.

(I)(We) further propose to do all Extra Work which may be required to complete the contemplated improvement at unit prices or lump sums to be agreed upon in writing prior to starting such work, or if such prices or sums cannot be agreed upon to perform such work on a "Force Account" basis, all as provided in 1904 of the Specifications.

(I)(We) further propose to furnish a Contract Bond in the amount of the Contract as security for the construction and completion of the improvement in accordance with the Plans, Specifications and Special Provisions, as provided in 1305 of the Specifications.

(I)(We) further propose to perform all work in accordance with the Plans, Specifications and Special Provisions and in a good and workmanlike manner, and to renew or repair any work which may be rejected due to defective materials or workmanship, prior to final completion and acceptance of the project by the Board of County Commissioners.

(I)(We) agree to all provisions of the most current edition of the Minnesota Statutes, Section 181.59.

(I)(We) further propose to begin work and to prosecute and complete the same in accordance with the time schedule set forth in the Special Provisions for the improvement.

SPECIAL PROVISIONS

1. Contract and Bond will be required. The successful bidder shall be required to **furnish a payment bond equal to the Contract amount and a performance bond equal to the Contract amount with the aggregate liability of the bonds equal to twice the full amount of the Contract. A Certificate of Liability Insurance will also be required, with coverage of \$1.5 million each occurrence and \$3 million general aggregate liability.**
2. Sales tax not to be included.
3. Materials to meet the requirements of the latest 2360 State of Minnesota Department of Transportation Specifications, for Plant Mixed Asphalt Pavement.
4. Plant-Mixed Bituminous Material (FOB Dept. Trucks)

The Plant- Mixed Bituminous Materials shall be in accordance with the provisions of 2360, except as modified below:

The Bituminous Material for Mixture shall be PG 58-28. The asphalt percentage in the mixture shall be 6.2%.

No Rap shall be allowed in the wear.

All testing shall be waived.

Air void shall be 4.0%.

5. The Contractor is not required to bid all items.
6. No compensation will be made for an increase or decrease in estimated quantities.
7. All materials will be made fully available to the Department from the period of June 1, 2015 to October 31, 2015.
8. Sales tax shall not be included in unit bid price. Lyon County is tax exempt and will provide an Exemption Certificate to low bidder.
